

## **SUPPORT PG CONTEST RULES**

### TERMS AND CONDITIONS

Entry exists solely online and consists of the following:

- Download the unique passport for rounds one, two, and three of the contest on our website at <https://www.supportpg.ca/> then print the passport associated with the round in which you are participating and start collecting Support PG stickers from businesses listed on the passport.
- Collect a minimum of five stickers on your passport for one entry into the prize draw. You will receive one entry per five stickers up to a maximum of five entries. Entries will reset at the beginning of each contest round for which a new passport will be posted to the website.
- For an extra entry each round, share a positive story about any of the participating businesses to your Facebook or Instagram timeline and tag @Support PG or use #SupportPG to make sure we see it. Bonus entries will reset at the beginning of each of the three contest rounds.
- Round one: Contest begins at 10:00 am PST on Wednesday, April 28, 2021 and ends at 11:59 pm PST on Thursday, May 27, 2021. Send us a picture of your completed passport via Facebook or Instagram or email it to [info@supportpg.ca](mailto:info@supportpg.ca) by the deadline. The random draw for a winner will take place at 9:30 am PST on Friday, May 28, 2021.
- Round two: Contest begins at 10:00 am PST on Friday, May 28, 2021 and ends at 11:59 pm PST on Tuesday, July 27, 2021. Send us a picture of your completed passport via Facebook or Instagram or email it to [info@supportpg.ca](mailto:info@supportpg.ca) by the deadline. The random draw for a winner will take place at 9:30 am PST on Wednesday, July 28, 2021.
- Round three: Contest begins at 10:00 am PST on Wednesday, July 28, 2021 and ends at 11:59 pm PST on Tuesday, September 27, 2021. Send us a picture of your completed passport via Facebook or Instagram or email it to [info@supportpg.ca](mailto:info@supportpg.ca) by the deadline. The random draw for a winner will take place at 9:30 am PST on Wednesday, September 28, 2021.
- One unique prize winner drawn every contest round. No purchase or payment necessary to enter or win.

### ELIGIBILITY

All Canadian residents, except for those living in Quebec, are eligible to enter unless they are: a) an employee, representative or agent of the organizations that manage Support PG or b) an immediate family member of an employee. At any time, Support PG reserves the right to request from any individual who has participated in the Contest by submitting an Entry, proof of identity and/or eligibility to participate. Failure to provide proof within a reasonable time or the provision of false or misleading information could result in the Entrant's disqualification. Contest is subject to all applicable federal, provincial, territorial and local laws and regulations. Support PG reserves the right to disqualify any Entrants who, in Support PG's sole discretion, do not comply with these Terms and Conditions or who otherwise tamper with the entry process.

## SELECTION AND PRIZES

Three (3) unique winners will be selected to each win the Staycation package designated for each round. Packages will be randomly assigned to winners. The winners will have five (5) consecutive days to respond via Facebook, Instagram, email, phone or voicemail. Winners must arrange their prize by December 31, 2021, or the Prize will be forfeited. Blackout dates may apply, transportation not included, double occupancy unless otherwise stated.
